Natural resources





- ▶ Tuzla Canton has a variety of resources on which has developed a wide range of industrial production.
- ▶ Coal and rock salt are the two most important mineral resources in the region. The salt-bearing is the only of its kind in Bosnia and Herzegovina, and by the coal reserves this space is the largest energy sector of Bosnia and Herzegovina.




- ▶ Agricultural land covers 49% of the territory of the Tuzla Canton,
 - ▶ over one third of the total agricultural area of the Federation of Bosnia and Herzegovina.
- ▶ Canton also has significant hydropower. The most important water resource is the accumulation Modrac in Lukavac, with a volume of 100 million m³ of water and the area of 17 km². The most important waterways are rivers Spreca, Tinja and Drinjaca.

Energy

- ▶ The region has a large capacity to produce electricity.
- ▶ TPP Tuzla –the biggest energy capacity in Bosnia and Herzegovina



- ▶ Installed capacity - 715 MW
- ▶ Average annual generation of electricity – 3100 GWh
- ▶ Annual coal consumption - about 3.3 million tons of coal

Blok 7 TPP Tuzla

- ▶ Replacement cogeneration lignite unit




Mining

- ▶ Geological reserves of black coal in the Tuzla basin are estimated at 316 million tons, and of lignite to about 2.66 billion tons
 - ▶ (24% of the reserves of black and about 60% of the reserves of lignite in B&H)







Starting a Business

- ▶ The Company Law of the Federation of B&H (Official Gazette of FBiH No. 23/99, 45/00, 2/02, 29/03, 68/05, 91/07, 84/08, 7/09, 63/10 and 75/13) regulate the establishment, operation and termination of businesses in Federation of B&H.


Steps for establishing a business

- ▶ **1.STEP** - Establishment Contract (by notary)
- ▶ **2.STEP** - Payment of initial capital
- ▶ **3.STEP** - Registration at the competent court (municipality/district commercial court)
- ▶ **4.STEP** - Making a company stamp
- ▶ **5.STEP** - Opening a bank account in a commercial bank
- ▶ **6.STEP** - Registration of the company and staff at the Tax Administration
- ▶ **7.STEP** - The statement of the company founder about fulfillment of all requirements for starting activity (submit to the competent inspection department)

Tax benefits

- ▶ Law Corporate Income Tax
 - ▶ taxpayer, who in the year for which the corporate income tax is being determined, has achieved 30% of their total revenue by export to be exempted from the tax payment for that year.
 - ▶ The taxpayer who in the period of five consequent years invests into production in the value of minimum 20 million BAM, on the territory of the Federation of Bosnia and Herzegovina, is being exempted from the payment of corporate income tax for the period of five years beginning from the first investment year, in which minimum four million BAM must be invested.
 - ▶ If the taxpayer, in the time period of five years, does not achieve the prescribed census for investment, he loses the right of tax exemption, and the unpaid corporate income tax is determined in accordance with the provisions of the Law on Corporate Income Tax augmented for penalty interest payable for untimely paid public revenues.
 - ▶ The taxpayer who employs more than 50% of disabled persons and persons with special needs longer than one year is being exempted from the payment of corporate income tax for the year in which more than 50% disabled persons and persons with special needs were employed.

Incentives for foreign investors

Law on the Policy of Foreign Direct Investments of Bosnia and Herzegovina
(Official Gazette of B&H, 17/98, 13/03 and 48/10) ensures:

- ▶ National treatment of foreign investors, i.e., foreign investors have the same rights and obligations as residents of B&H.
- ▶ Foreign investors are entitled to open accounts in any commercial bank in domestic and/or any freely convertible currency on the territory of B&H.
- ▶ Foreign investors are entitled to freely employ foreign nationals, subject to the labor and immigration laws in B&H.
- ▶ Foreign investors are protected against nationalization, expropriation, requisition or measures having similar effects; such measures may take place only in the public interest in accordance with the applicable laws and regulations and against the payment of an appropriate compensation, i.e. compensation that is adequate, effective and prompt.
- ▶ Foreign investors are entitled to transfer abroad, freely and without delay, in convertible currency, proceeds resulting from their investment in B&H
- ▶ Foreign investors may own real estate in B&H. Foreign investors enjoy the same property rights in respect to real estate as B&H legal entities.

The most important foreign investments in Tuzla canton
